The 2010 Artemis Great Kindrochit Quadrathlon will fund Mercy Corps work to improve food production in poverty stricken Guatemala.

The project supported by the Quadrathlon, is the vital next stage in helping families to maximise the potential of their land, grow sustainable and profitable crops, and generate livelihoods for themselves and future generations. 9,000 people will directly benefit from this project and the knock on effect will be to secure a stream of diverse, nutritional food and to increase food security of the entire populations of the 25 communities in which this project works.
